**NOTICE IS HEREBY GIVEN**, that sealed Bids are sought and requested by the Elizabeth Board of Education (hereinafter called "Owner"), for AUTO BODY SHOP SPRAY BOOTH REPLACEMENT AT THOMAS EDISON HIGH SCHOOL #87; together with all work incidental thereto, in accordance with Drawings and Specifications prepared by EI Associates, 8 Ridgedale Avenue, Cedar Knolls, NJ 07927.

Description of Contract: Single Overall Contract (Lump Sum, all Trades, all inclusive).

Description of Project: The work of this project includes, but is not limited to, removal and replacement of the existing auto spray booth and mixing booth, new exhaust, ventilation, lighting, electrical power, compressed air system modification, fire suppression, concrete floor slab demolition and reconstruction, and sump pit.

**Each Bid shall be accompanied by a Bid Bond, cashier's check or certified check made payable to the Elizabeth Public Schools for ten percent (10%) of the amount of the total bid, however, not to exceed \$20,000.00.**

Pre-bid Meeting:

One (1) prebid meeting will be held at the Thomas Edison High School (School #87), in Conference Room 106B, at 625 Summer Street, Elizabeth, NJ 07202 at 10:00 a.m., Prevailing Time, June 22, 2026. The meeting will be followed by site visits to all of the project sites. This meeting is conducted for the purpose of considering questions posed by Bidders. All Bidders are strongly encouraged to attend this meeting. Meeting minutes will be prepared and distributed to all Bidders who have received bid specifications.

Bid proposals for the above Contract will be received from Bidders registered with the Division of Revenue and Department of Labor. All Bidders proposing to Bid shall be classified in accordance with N.J.S.A. 18A:18A-27, as to the character and amount of public work on which they shall be qualified to submit a Bid by the Department of Treasury, Division of Property Management and Construction (DPMC). Bidders shall submit with the Bid current prequalification certificates issued by the DPMC for one of the following classifications:

General Contractor with a DPMC Classification of C008 General Construction, or

General Contractor with a DPMC Classification of C009 General Construction/Alterations and Additions

In addition, the Bidder is required to submit with the Bid, a current prequalification certificate issued to the Bidder or its subcontractor by the DPMC, for the following DPMC Specialty Trades:

Plumbing:	C030
HVACR:	C032
Electrical:	C047

Each Bidder shall also be registered pursuant to the Public Works Contractor Registration Act, N.J.S.A. 34:11-56.48 et seq. and shall provide a valid and current registration certificate with its Bid as to the bidder and all subcontractors, at the time the proposal is received by the Elizabeth Public Schools.

Any Bid submitted without a copy of valid and active prequalification/classification certificates may be rejected as non-responsive to the Bid requirements.

Each Bidder shall submit with its bid, a Prequalification Affidavit – No Material Adverse Change, a copy of a valid and active NOTICE OF CLASSIFICATION, a certified copy of a Total Amount of Uncompleted Contracts form and such Affidavit that subsequent to the latest such statement submitted there has been no material adverse change in his qualification information except as set forth in said Affidavit.

Statement of Ownership Requirement: Pursuant to N.J.S.A. 52:25-24.2, Bidders shall submit a statement setting forth the names and addresses of all persons and entities that own ten percent or more of its stock or interest of any type at all levels of ownership.

Each Bidder shall submit with its bid, a Consent of Surety as per N.J.S.A. 18A:18A-25 from a Surety company

licensed to write business in the State of New Jersey, stating that the Surety will provide the successful bidder and its subcontractors with a performance/payment bond in the full amount of the contract.

The bid package will also include other documents that must be completed and returned with the bid. Failure to comply with Instructions to Bidders and to complete and submit all required forms may be cause for disqualification and rejection of the bid.

The Elizabeth Board of Education requires that all Bids shall comply with the bidding requirements specified herein and in the Request For Proposal. The Elizabeth Board of Education may waive informalities in Bids in accordance with the law. The Elizabeth Board of Education also reserves the right to reject any non-responsive bids or all Bids pursuant to N.J.S.A. 18A:18A-22.

No bidder may withdraw his bid withing (60) sixty days after the actual date of the bid opening thereof, 18A:18A-36a. The Owner reserves the right extend this date as negotiated with the potential low bidder.

Attention of the Bidders is particularly called to the requirements of employment to be observed and minimum wage rates to be paid under the Contract pursuant to N.J.S.A. 34:11-56.25 et seq.

In accordance with the provisions of of N.J.S.A. 10:5-33, all Bidders are placed on notice that they are required to comply with the requirements of P.L. 1975, Chapter 127. (NJAC 17:27).

All Bidders must submit a Business Registration Certificate, Certificate of Employee Information Report, and a Political Contribution Disclosure Form with their Bid Package.

All Bidders must comply with N.J.S.A. 18A:18A-20 "American Goods and Products to be used where possible."

Bidding shall be in conformance with the applicable requirements of N.J.S.A. 18A:18A-1 et seq., pertaining to the "Public School Contracts Law.

All Bidders are placed on notice that they are required to comply with all requirements of the Laws Against Discrimination, N.J.S.A. 10:2-1 et seq. and the Affirmative Action Regulations, N.J.S.A. 10:5-31 et seq. and N.J.A.C. 17:27 and provide the appropriate documentation at the time specified in the Request For Proposal.

No bidder who is on the State Treasurer's or Federal Government's List of Debarred, Suspended or Disqualified Bidders shall be eligible to bid on this project.
